RACINE COUNTY COVID-19 UPDATE December 14, 2020

Confirmed coronavirus cases

United States: 16,351,259 confirmed, 299,889 deaths

Wisconsin: 438,895 confirmed, 2,255,994 negative, 4,068 deaths

Central Racine County Health Department: 8,203 confirmed (+539 from last week), 1,023

Updates for the week of December 14:

- The first COVID-19 vaccinations in the United States were administered today -- a significant milestone after the extraordinarily challenging last nine months. The Central Racine County and City of Racine Public Health Departments, along with the Racine County Emergency Operations Center (EOC), are preparing for COVID-19 vaccinations in coordination with other local partners. Local officials are urging residents to remain patient and continue to follow all public health measures to slow further COVID-19 transmission until the vaccine is widely distributed. - While the most recent schedule of Wisconsin National Guard drive-thru testing has expired, the Guard is expected to maintain a presence in Racine County for testing, and both the Central Racine County and City of Racine Health Departments are working through details. The onset of winter weather brings new logistical challenges for drivethru testing, particularly with finding locations for testing that meet the new State requirements to ensure the safety and welfare of the National Guard. We hope to release updated information soon.
- Residents who are experiencing COVID-19 symptoms, were in close contact with someone sick with COVID-19, or who recently attended a gathering are encouraged to get tested by contacting their health care provider or by visiting https://www.dhs.wisconsin.gov/covid-19/community-testing.htm or lmpact-2-1-1 for community testing sites.
- Over 1,400 residents are currently hospitalized in Wisconsin due to COVID-19, with over 20 percent of those patients in the ICU. Hospitals across the state report 18% of beds available. The alternative care facility at State Fair Park, which serves as an overflow facility for state hospitals, has six patients as of today, Dec. 14.
