RACINE COUNTY COVID-19 UPDATE March 29, 2021

COVID-19 cases

United States: 30,291,863 confirmed, 549,664 deaths

Wisconsin: 576,044 confirmed, 2,712,235 negative, 6,601 deaths

Central Racine County Health Department: 12,653 cases (combined confirmed and probable), 64,618 negative, 210 deaths

City of Racine Public Health Department: 9,373 cases (combined confirmed and probable), 46,990 negative, 116 deaths

Racine County total: 22,026 cases (combined confirmed and probable), 111,608 negative, 326 deaths

Updates for the week of March 29:

- Appointments are available at the community-based COVID-19 vaccination clinic at Regency Mall in Racine. Residents should register at <https://vaccinate.wi.gov>. The clinic is open 11 a.m. to 7 p.m., Tuesdays through Saturdays, in the former Burlington Coat Factory location. Enter in the southwest entrance next to Planet Fitness.
- Residents can also register and access more vaccine information by phone by calling 844-684-1064 (interpreters available for non-English speakers).
- Last week, the Wisconsin Department of Health Services and laboratory partners confirmed a third variant strain of SARS-CoV-2, the virus that causes COVID-19. This variant spreads more rapidly and easily than the original strain. Additionally, the CDC has warned of another potential wave of cases. Residents should continue to be vigilant and follow public health guidelines to help avoid an increase in COVID-19 cases. [Read more here.](#)
- The Wisconsin National Guard is conducting drive-thru COVID-19 testing at Festival Hall in the City of Racine on Mondays from 9 a.m. to 1 p.m. Pre-register by visiting <https://register.covidconnect.wi.gov/en-US/>.
